A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, PENNSYLVANIA, PROVIDING FOR THE EXTENSION OF THE DISCOUNT PERIOD TO PAY TOWNSHIP REAL ESTATE TAXES UNTIL AUGUST 31, 2020; PROVIDING FOR THE WAIVER OF FEES AND PENALTIES FOR THE PAYMENT OF TOWNSHIP REAL ESTATE TAXES PROVIDED THAT THE SAME IS PAID IN FULL BY DECEMBER 31, 2020 IN ACCORDANCE WITH THE PROPERTY TAX RELIEF PROVISIONS OF ACT 15 OF 2020.

WHEREAS, the Township of South Fayette ("Township") is a Pennsylvania First Class Township; and

WHEREAS, Act 15 of 2020 authorizes taxing districts, including townships, that impose taxes on the assessed value of real property, to provide certain relief to taxpayers for the 2020 tax year; and

WHEREAS, the Board of Commissioners has determined that it is in the best interests of the Township, its residents and taxpayers, for the Township to provide relief to those paying taxes on the assessed value of real property located within the Township, but solely for the tax assessed, imposed, and levied, for the 2020 calendar year, and not for delinquent taxes for prior years;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ENACTED, BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE, AND IT IS HEREBY RESOLVED AND ENACTED AS FOLLOWS:

- 1. The Township of South Fayette hereby extends the period in which it will collect the tax imposed on the assessed value of real estate at the Township's prescribed discount rate through August 31, 2020.
- 2. The Township hereby waives any fees or penalties associated with the late payment of the tax imposed on the assessed value of real estate, provided that the tax is paid in its entirety by December 31, 2020. The waiver is only provided for the tax assessed, imposed, and levied, for the 2020 calendar year, and not for delinquent taxes for prior years.
- 3. This Resolution is to take effect upon adoption.
- 4. Any Ordinance or Resolution, or portion thereof, conflicting with the provisions of this Resolution shall be and the same is hereby repealed, insofar as the same affects this Resolution.
