**RESOLUTION No. 08 -2014**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SOUTH FAYETTE TOWNSHIP, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA, AMENDING AND RESTATING THE RULES AND REGULATIONS FOR THE CIVIL SERVICE COMMISSION OF SOUTH FAYETTE TOWNSHIP IN THEIR ENTIRETY.**

WHEREAS, the Township of South Fayette is a First Class township located in Allegheny County, Pennsylvania; and

WHEREAS, on January 20, 2003, the Township of South Fayette, by Resolution 1 of 2003, amended and restated its' Civil Service Rules and Regulations in their entirety; and

WHEREAS, on August 15, 2011 by Resolution No. 8 of 2011, the Township of South Fayette further amended portions of its Civil Service Rules and Regulations, ; and

WHEREAS, on February 19, 2007 by Resolution No. 02 of 2007, the Township of South Fayette amended Section 4, Subsection 4.7, of its' Civil Service Rules and Regulations by revising the Physical Fitness testing requirements for all new applicants; and

WHEREAS, the Civil Service Commission of the Township of South Fayette has recommended to the Board of Commissioners of the Township of South Fayette that the Civil Service Rules and Regulations be amended and restated in their entirety to conform to current Civil Service requirements under the First Class Township Code; and

WHEREAS, the Civil Service Commission of the Township of South Fayette adopted said recommendations at its' August 20, 2014 regular meeting; and

WHEREAS, it is the desire of the Board of Commissioners of the Township of South Fayette to implement said recommendations by adopting revised and restated Rules and Regulations as presented and recommended by the Township's Civil Service Commission:

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE, THAT THE ATTACHED REVISED AND RESTATED CIVIL SERVICE RULES AND REGULATIONS ARE HERBEY ADOPTED IN THEIR ENTIRETY.
